

# WALPOLE PARISH COUNCIL MEETING

1. Welcome from the Chairman followed by Public Participation: None
2. Apologies received – Cllrs Campion, Green, Luck and clerk
3. All Councillors were reminded of their duty to abide by the Code of Conduct.
4. Declarations of interest – None
5. Minutes approved from the Parish Council meeting on the 4th of December proposed by Cllr Bliss, seconded Cllr Hunter and all in favour who were present at that meeting.

## 6. Matters arising:

6.1 National Grid update: James Wild MP is prepared to visit us and awaiting results of a survey ahead of arranging a date. Cllr Blunt will chase and update. **ACTION: RB**

6.2 New Dog bin on Dunces Lane – Cllr Bliss advised that this has not yet been installed due to the recent bad weather. The clerk to find out the position of any utilities to enable installation as may need to dig down. This may involve additional costs. **ACTION: Clerk**

7.1 Councillor's reports – Street lamp no. 3 on Police Road still flickering and clerk to report. **ACTION: Clerk**

Church Road needs to be gritted.

Cllr Eveleigh reported that the Crown Farm sugar beet lorries have caused parishioners complaints and has advised the clerk.

Cllr Bliss rang planning to ask about enforcements and was given an email address and told this can be used to follow up enforcements as sometimes nothing seems to be happening.

7.2 **County Councillor Report** – nothing from County to report but has received complaints regarding Church Road not being gritted. Cllr Blunt asked what we can do about this and Cllr Kirk advised that anything on this side of the A47 is not gritted. It was suggested that the Clerk write to NCC to see if the gritting route can be changed. Depending on the response, include the Borough Councillor and MP. If we could find out the costs to grit Church Road at the same time.

**Borough Councillor Report** –budgets are currently being worked on and there a full budget meeting on the 26<sup>th</sup> of February with a cabinet meeting on the 3<sup>rd</sup> of February. No information for the precepts as yet. The Government is making changes which affects costs and services. Systems are being changed to make savings.

**7.3 Chairmans Report** – Cllr Boston has met with the Chair of Epping District Council and discussed the future of Parish and County Councils etc.

**Clerk Report:** Still working with Scribe and NPTS regarding the new assertion 10 rules and regulations. Additional polices as approved and now on the website with the IT equipment form to be signed by each Councillor at the February meeting. Now working on the required Data Map and relevant risk assessment Parish Public Access Consultee Training – part of the testing group for the new online planning portal – now set up with access.

The councillor vacancy has been advertised on the website and co-options to be held at the February meeting.

**7.5** To receive updated regarding footpaths and circular walks – Cllr Eveleigh reported that are being used thanks to the grass being lower.
